5. I further agree that the machine that I enter and compete on shall be suitable and proper for the purpose and that it will comply with the regulations respect thereof, and is described below.
6. I understand and agree that I am required to register my arrival by signing on at the event office or other designated area not less than 30 minutes prior to commencement of the event.
